**Camp Costs:**

- **\$250 per session, per week (5, 3 hour classes)**
- **Come back a 2<sup>nd</sup> week for \$225**
- **Refer a friend and come back with them for \$200!!! (Your friend must list you as person who referred them to camp and they must pay in full for camp before you can receive your discount.)**
- **Before care and after care (7:30 – 9am or 12 – 1pm) \$50/week or \$10/day.** After care **MUST** be arranged in advance! If your child is picked up more than 15 minutes late and not on aftercare, you will be charged \$1/minute after 15 minutes.

**\*\*\*\$50 deposit required to hold spot. Balance due by May 15<sup>th</sup> for ALL weeks of Camp! We will call to remind you ☺.**

## **Terms for the 2008 Season Day Camp Enrollment:**

**Age Requirements:** Campers must be between the ages of 7 & 15 during their camp session.

**Upon Receipt of Registration:** Each camper will receive an enrollment confirmation by mail. If you have not received your confirmation packet within 10 business days please call the office to confirm receipt of your registration.

**Liability Release Forms:** All campers are also required to have a current Liability Release Form on file in the office during their stay. The form will be included with your confirmation packet or can be down loaded off our website

[www.edenoaksfarm.com](http://www.edenoaksfarm.com) and included with your registration and payment.

**The Liability Release Form and Medical Form must be in our office by May 15, 2008.**

**Dismissal of Camper:** The camp reserves the right to dismiss, at it's sole discretion, any camper whose condition, conduct, influence, or behavior is deemed unsatisfactory or detrimental to the best interest of the Camp or her/his fellow campers or who violates Camp rules and regulations, in which case no refunds will be made.

**Extended Care:** This is a service that is provided for campers who because of transportation issues need to arrive at camp early and/or stay after camp is over. Extended Care Hours - 7:30 -9am. *Please Note:* campers not on extended care should be picked up no later than 12:15pm. Parents will be charged \$1 per minute after 15 minutes for campers not picked up on time. (Same applies for campers dropped more than 15 minutes early!!)

**Late Arrival/Early Departure:** No reduction in enrollment fees will be made for late arrival of early departure of camper.

**Waiting Lists:** Registrations are accepted on a first come, first serve basis. When all available spaces are full a wait list will be created.

**Please Read: Cancellation Policy:** The camp fee includes a \$50 per session non-refundable/non-transferable deposit. For any cancellation received prior to final payment deadline, the camp fee will be refunded minus the non-refundable deposit (\$50 per session). **In order to provide the highest quality horse program we must plan well in advance based on confirmed reservations.**

**For that reason, after the final payment date for your child's camp session no refunds will be issued for cancellations.** If spots are available in other camps, child can switch to another date free of charge. If camper is unable to attend due to documented (doctors note) illness or injury, payment minus \$50 deposit (\$200), may be transferred to use for lessons. Final payments for summer camp sessions will be due on/before May 15th.

- Eden Oaks requires at least 4 paid campers per session. If session is cancelled or combined due to low enrollment, camper may switch to another week, use balance for lessons, or receive full refund.

**\$35 returned check fee.**

**Important Additional Information:**

It is important for parents and campers to know that we do not allow the following items to be brought to camp. Any of the following items that make their way to camp with your camper will be held safely in the camp office until checkout time.

- CD players, IPOD/MP3 players, etc.
- TVs, Video games, GameBoys, etc.
- Cell phones, pagers
- Pocketknives, slingshots, weapons etc

We are not capable of accommodating parents or additional friends/family members that are not enrolled in camp to stay during the sessions. On the last day of camp, parents and other guests are invited to stay for all or part of the session to take photos and see what your child has learned!

We thank you in advance for helping us to, insure the safety of our campers and staff by respecting our policies for attending camp at Eden Oaks Farm.
